13. Item No.369/FC.2017.XII - ANY OTHER MATTER:

 GRI CENTRE in New Delhi : The Vice-Chancellor informed that on directions of the Chancellor, the work of establishing GRI Centre in New Delhi is going on in full swing. A Committee consisting of the following members was constituted by the Vice-Chancellor to frame guidelines for GRI Centre:

1. Registrar ... Chairman

2. Special Officer (Finance) ... Member

3. Dean, School of Health Sciences and

4. Director (Academic) ... Member

5. Director (International Programmes) ... Member (Convenor)

The Committee met several times and recommended the wooden, glass partition, interior and exterior wall decorations, electrical and electronic works to be carried out, furniture and fittings, etc. The expenditure towards establishing the GRI Centre in New Delhi is being incurred from the General Development Fund. Till date, a sum of Rs. 48.75 lakhs has been sanctioned / advanced for the works / purchases made for establishing GRI Centre in New Delhi. The location of GRI Centre is at 113, Hargobind Enclave, Delhi – 110 092.

- 2. The Finance Committee suggested to maintain separate ledgers for (i) GRI Building and Development Fund Account (ii) GRI Scholarship / Fellowship Fund Account so that the donations received for the specific purpose could be spent for that purpose. The receipts and payments of such donations shall be accounted in the Corpus Fund.
- 3. The Finance Committee suggested that our Investments need not be made in Financial Institutions which are not ranked as 'AAA'.
- 4. An Investment Policy may be prepared and placed in the next Finance Committee meeting.
